Indian Institute of Information Technology Allahabad Prayagraj, U.P. India, 211015 IIIT Allahabad is an Institution of National Importance, established by the Govt. of India in 1999. It is since then that it has been in the service of nation in field of Information Technology and Allied Areas. It offers B.Tech. MTech, PhD and various Dual Degree Programs in Technology areas while MBA through its Management Studies Department. Now IIIT Allahabad invites eligible candidates to apply for the various Post Graduate Programs as follows :

This call of applications, is in anticipation of seats becoming available for both GATE Qualified as well as Non- GATE Candidates after admissions at the Institute are offered to all confirmed by CCMT 2025. This should NOT be construed as an alternative mechanism for admissions to MTech / MTech-PhD Dual Degree Programs of IIITA, running in parallel to the CCMT Admissions. This channel of admission is purely to fill the vacant seats, if any, after completion of admission through CCMT 2025.

In case all seats are filled through CCMT 2025 Allotments, then all applications shall be treated as cancelled and application fees shall be refunded in full.

Important:

- For GATE Qualified and VALID GATE Scores holders, admission shall be based upon GATE Scores ONLY while for NON-GATE candidates, admissions shall be on the basis of National Level Open Computer Based Test of IIIT Allahabad.
- 2) Candidates whose GATE Scores have become time barred shall be treated as NON-GATE candidates for the purpose of these admissions.
- 3) GATE Scores of 2023, 2024 or 2025, all shall have equal weightage.
- 4) In case of candidates having a tie on the GATE Scores, the one with older GATE Passing Year shall be given priority i.e. the candidate of 2023 will be given priority over 2024 or 2025. In case of tie between two candidates of same GATE year, priority shall be given to the candidate having higher marks percentage in Undergraduate Degree.
- 5) Subject to seats lying vacant after final admissions on seats allotted by CCMT 2025,

available program-wise, category wise seats shall FIRST be opened for offer to candidates who are GATE Qualified and in possession of a VALID Score.

- 6) Only in case of seats lying vacant after exhaustion of Valid GATE Qualified candidates, shall the same be opened for offer to NON GATE Qualified Candidates. Such candidates shall be offered the seats, after they qualify in the National Level Open Computer Based Test (CBT), to be held at IIIT Allahabad premises at Prayagraj. Modalities and other details shall be conveyed to the eligible candidates separately, through display on <u>www.iiita.ac.in</u> .CBT will be of 100 marks and Objective Multiple Answer Choice. - 7) In all cases, seats availability shall be assessed category-wise.
- 8) In case all seats are filled with GATE Qualified candidates such that no seats are available for offer to NON-GATE Candidates, then in that case, applications from NON-GATE candidates shall be treated as cancelled and their application fees shall be refunded in full.
- 9) It is mandatory that the candidates applying, MUST have the clear pass final Degree Marksheet in their hand at the time of physical reporting for admissions at the Institute.
- 10) Eligible Branches / Disciplines of B.Tech. / M.Sc. Degrees: Refer Annexure A.
- 11)Application Fees: For Gen / EWS / OBC Candidates Rs 600/- while for SC / ST / PwD Candidates Rs 500/- Candidates making applications for Programs offered by different Departments shall be required to make separate applications department-wise and pay the fees separately. For different Programs of same department, only one application shall suffice.
- 12)Specialisation shall be decided at the time of admissions for ECE and AS Department while for IT Department, only Group shall be decided at the time of admission.
- 13)**Information Technology Department Specific Seats:** The admissions are initially offered in the three Groups as shown in the table above. The Specializations shown in the Table above, would be allotted, after the completion of the First Semester, depending upon the merit drawn after seeking priorities from the students, based upon their First Semester Scores.
- 14)While the GATE Qualified Candidates are eligible for GATE Stipend, the NON-GATE Candidates shall not be eligible to receive the GATE Stipend and nor is there any IIITA's commitment for any alternative Stipendiary / Other type of financial support, for pursuing the enrolled Degree Program.
- 15)Institute Fees and Dues are applicable uniformly on all GATE / NON-GATE candidates.
- 16) After admissions, there shall be no academic differentiation in GATE or NON-GATE candidates, except for the purpose of GATE Stipend payment.
- 17)All Programs are fulltime Residential Programs and governed by NEP Aligned Curriculum of IIIT Allahabad, Prayagraj and further subject to the decisions taken by the Senate of the Institute from time to time. Decisions of the Senate are binding upon all.
- 18) At the time of filling up of the online application form, whatever information is being filled in by the candidate is being treated as correct by IIIT Allahabad. The same details shall remain sacrosanct and no change / alteration of any kind shall be allowed later. All information filled in by the candidates at the time of applying shall be required to be supported by relevant documents, failing which the offer of admission shall stand cancelled forthwith. Institute further reserves the right to get the documents / facts verified from various agencies / institutions. In case of any incorrect / false / misleading information, admission may be cancelled at any stage.
- 19) This being Institute Spot Round of Admissions, desirous candidates, who are offered admission, shall have to take the admission on the spot, then & there, by producing all relevant documents in Original, payment of applicable Fees etc. In case of any non-compliance, the offer of admission shall be treated as withdrawn with immediate effect and the seat shall be offered to the next candidate on the merit list. No time allowance on any ground shall be allowable. Interested candidates must therefore come fully prepared.

- 20)Candidates shall be called in Order of Merit (GATE Scores for GATE Qualified candidates and Computer Based Test Score for NON-GATE candidates). If the candidate doesn't present himself/herself in person, immediately thereafter, s/he shall loose his priority with no further claim. In case however, such candidate appears later, s/he may be considered for admission subject to availability of seat on that instant, without any relationship to the earlier call.
- 21)Hostel shall also be allotted to the admitted candidate(s) immediately after admission. Separate accommodation for Boys and Girls, exists on campus.
- 22)Applicable program fee is as shown at Annexure-1.
- 23)List of Documents etc. required at the time of admissions is as shown at **Annexure-2**. Additionally, candidates are required to carry one set of clear and legible, good quality Photocopies of all the listed documents, at the time of physical reporting for admission.
- 24)All further updates / notifications / information in respect of these admissions shall be displayed on the Institute website www.iiita.ac.in. Candidates are therefore advised to keep visiting the same frequently. No individual intimation of any kind shall be sent to candidates.
- 25) Decision of the Director IIIT Allahabad shall be final and binding upon all.
- 26) If sufficient numbers are not admitted to a particular specialization, then Institute May not run that concerned specialization.
