Kindly mention enquiry reference number, subject, due date contact address etc on envelops. Incomplete quotation will not be accepted.

Note:

- The firm must have the registration in PWD, CPWD, MES or other Govt./Semi Govt.
 department in appropriate class. The certificate of same should be submitted along with
 offer.
- Minimum turnover of the firm should be Rs.10 lakh or more in last two financial year (2015-16 & 2016-2017).
- 3. Work to be executed at IIIT-A, Deoghat Jhalwa, Allahabad.
- 4. Quoted rate should be valid at least for 60 days.
- Enquiry/tender must be quoted in prescribed format on the letter head of the firm/vendor, otherwise quotation may be rejected.
- 6. Work should be completed within 5-6 weeks from the receipt of the Work/Purchase order. If, the work/supply delayed beyond the stipulated time of completion of work/supply penalty of 1% per week of total cost may be imposed at the discretion of competent authority. The penalty may be upto 10% of the total cost.
- 7. If it is found that items are fake or of sub-standard quality and not conforming to the required specifications, the firm, will have to replace the lake/ sub-standard items with genuine ones immediately but they will also be liable to be blacklisted.
- 8. Rate quoted by the firm should not be higher than the MRP/ prevailing market rate.
