The centrifuge must be offered with swinging bucket, fixed angle and micro plate rotors to meet current and future sample processing needs of the lab. 2. RPM should be in the range of 16,000- 20,000 and RCF at least 25,000 g or better. 3. Should be CE marked, IVD compliant & UL listed instrument for safety containment. 4. System should be capable to run on the Temperature range between -10°C to 40°C in routine use on required temperature setting. 5. Rotor exchange should be in 5-10 seconds without any tool with auto lock technology to change over number of rotors should be easily possible for frequent use. 6. The centrifuge must have provision for direct recall program keys. 7. System should be offered with 3 years warranty and Suitable Stabilizer is also required with the instrument for proper running/uses.	01		

8. Following Rotors must be quoted with the instruments for its proper use. I. Fixed Angle Rotor for at least 24 x1.5 ml at RPM: atleast 14000 & RCF at least 25,000g. II. Fixed angle rotor 6 x50 ml & adapter for 6x15 ml with RPM atleast 9,500 & RCF approx 12,000 g or better for cell culture application. III. Swinging bucket Rotor for 8 x 50ml & 15 ml conical tubes. With RPM: atleast 4500 and RCF 3200xg or better.

- FOR destination IIIT-Allahabad.
- Annual Turnover of the firm should be 25 Lakh or more for the last two financial years i.e. 2015-16 & 2016-17. (Profit and loss account duly certified by CA should be provided as attachment with each bid).
- The vendor should have supplied minimum order of 10 lakh or above for the equipments in last two years (Documentary proof required).
- Bidder must submit minimum 2 copies of purchase order during last 02 financial year (2016-2017) from Central or State Govt. Institutes/organizations for qualification in the bid.
- Quoted rate should be valid at least for 60 days.
- Enquiry/tender must be quoted in prescribed format on the letter head of the firm/vendor, otherwise quotation may be rejected.
- Work should be completed within 05-06 weeks from the receipt of the Work/Purchase order. If, the work/supply delayed beyond the stipulated time of completion of work/supply penalty of 1% per week of total cost may be imposed at the discretion of competent authority. The penalty may be upto 10% of the total cost.
- If it is found that items are fake or of sub-standard quality and not conforming to the required specifications, the firm, will have to replace the fake/ sub-standard items with genuine ones immediately but they will also be liable to be blacklisted.
- Rate quoted by the firm should not be higher than the MRP/prevailing market rate.
- Conditional quotations are liable to be rejected. In the event of acceptance, Director's decision will be final. The rates should be quoted as per our required specifications. The quotation which is not as per our required specifications, will not be considered on any ground.

14. All the documents submitted must be legible and self attested. Otherwise it is likely to be rejected.

16. **Security Deposit:** L1 bidder will have to submit Bank Guarantee/FDR of 10% of total contract value within 10 days from Nationalized Bank against performance bank guarantee which will be released after two month of the completion of the work. EMD submitted with tender document will be released after submission of Security Deposit for the successful bidder.
17. EMD should be in a form of Demand Draft/FDR in favour of "**Indian Institute of Information Technology Allahabad**" payable at "**Allahabad**" (**Any tender/quotation without EMD will not be considered**).
18. The EMD shall be returned to the bidder (s) whose offer is not accepted by the Institute within 15 days after finalisation and award of the contract without any interest. Unsuccessful bidders may collect the EMD (within next 10 days after finalization & award of the contract) from Store and Purchase Section, IIIT-A between 3PM to 5PM on any working day after providing a copy of any Photo Identity Card. After these 10 days EMD will be sent by registered post to the postal address provided by the firm/bidder at point no.19.
