i) Eligibility criteria:

- 1. The firm should be an Original Equipment Manufacturer (OEM) or authorized service provider of the OEM for specific license (attach documentary proof). The Tender Specific authorization issued by the OEM must be valid and enclosed.
- 1. OEM/Authorized Agencies should have experience in developing similar portal for other clients (proof of document).
- 2. Provided services in Govt. Organization/Educational Institution with the minimum work order value of Rs. 2.00 lakh (copy of the work order along with successfully completed Project feedback/report should be attached.)
- 3. Adequate number of Technical Personnel on its Pay Rolls for the purpose.
- 4. All necessary registration, OEM certifications and documents signed by the Director or head of the organization.
- 5. Minimum turnover of Rs 20.00 lakh Per Annum. Start-ups will be exempted on production of relevant certificate. (Attach balance sheet for three last years).

Remaining 10% will release on after receiving of Performance security.
- 2. Payment will be paid only if required SLA as mentioned in scope of work is met.
- 3. No interest is payable on the PBG. In case the bidder is not able to execute the work as per terms, EMD/PBG shall be forfeited. PBG will be realized by IIT-A in case of termination of the contract for unsatisfactory performance and/or non performance of the contract.

iv) Terms and Conditions:

- 1. FOR destination, IIIT-Allahabad.
- 2. Enquiry/tender must be quoted in prescribed format on the letter head of the firm/vendor, otherwise quotation may be rejected.
- 3. Rate quoted by the firm should not be higher than the MRP/prevailing market rate.
- 4. Quotation received by firm OEM bidder is an authorized partner or service provider/Channel Partner a valid agency ship (MAF specific to this enquiry) to quote on behalf of OEM.
- 5. Quoted rate should be valid at least for 60 days from the last date of submission.
- 6. Supply & Installation must be completed within 10 days from the receipt of the Purchase order. If, the supply delayed beyond the stipulated time of completion penalty of 1% per week of total cost may be imposed at the discretion of competent authority. The penalty may be upto 10% of the total cost.
- 7. IIIT-A does not bind itself to accept the lowest or any other offer and reserves the right to accept or reject any or all the offers either in full or apart without assigning any reason.



- 8. The firm should have their own test and repair facility with certified engineers.
- 9. The status as on date for selling of product may and scrutinize examine by the Committee.
- 10. Vender should submit copy of GSTIN registration certificate with quotation.
- 11. Bidder should provide details of its support, certification to this effect from the OEM.
