1. PREQUALIFICATION CRITERIA FOR BIDDER

1.1 Bidder should have technical experience of having successfully completion Certificate of similar Nature of work during the last 3 years in any Central/state Government/PSU/Autonomous bodies in appropriate class like CPWD, MES, PWD/central University & Any other Govt. Institute/Organization/Departments/Nagar Nigam etc. **Before last date of tender submission for the purpose of consideration as technical experience.** Bidder should Satisfying below condition with in the last years. For the purpose of consideration as technical experience bidder should Satisfying below condition:

1.1.1 One work completion Certificate costing not less than **Rs.0.40 Lakhs.**

OR

1.1.2 Two work completions Certificate each costing not less than **Rs. 0.25 Lakhs.**

OR


1.1.3 Three work completions Certificate each costing not less than **Rs. 0.20 Lakhs.**

(Attested copies of all the above work Completion certificates must be submitted along with the tender).

- 1.2 The bidder should submit proof of average annual turnover of Rs. 0.25 Lakhs for the Last 3 financial years (2021-22, 2022-23 and 2023-24). Audited and certified copies of balance sheet, letter mentioning turnover and profit and loss statement of these three years duly certified by chartered accountant should be submitted.
Note: If any bidder does not furnish the turnover value for any financial year out of the last 3 financial years, the turnover for that financial year shall be taken as 'Zero' and the average annual financial turnover shall be calculated accordingly.
- 1.3 Contractor must be registered in Central/state Government/PSU/Autonomous bodies in appropriate class like CPWD, MES, PWD & any central University Nagar Nigam etc. The validity of the registration should be for the current year clearly mentioned on the registered copy. (Attach self-attested documentary evidence showing its current validity)
- 1.4 Bidder must have a registered office in India. An undertaking on letter head of the firm by mentioning, the office details, contact no, & contact person etc.
- 1.5 Any IIT/IIIT/NIT/ Government Department/PSU/PSU Banks/Autonomous Bodies/ Statutory Bodies/ Central Universities in India should not have blacklisted the Bidder at any stage. Self-declaration to that effect should be submitted along with the technical bid on company letter head.
- 1.6 The firm must have valid GST Registration Certificate by showing the registered office address, GST no., Contact no. & person. (Attach self-attested copy)
- 2. Other Terms and conditions :**
 - 2.1 FOR destination IIIT-Allahabad.
 - 2.2 Quoted rate should be valid at least for 60 days.
 - 2.3 The mention quantity is approx quantity; it may vary as per CPWD Norms. The payment will be made as per actual basis.
 - 2.4 Enquiry/tender must be quoted in prescribed format on the letter head of the firm/vendor, otherwise quotation may be rejected.
 - 2.5 Work must be within 04 weeks from the date of agreement. If the supply delayed beyond the stipulated time of completion of supply, penalty of 1% per weeks of total cost may be imposed at the discretion of competent authority. The penalty may be up to 10% of the total cost.
 - 2.6 If it is found that items are fake or of sub-standard quality and not conforming to the required specifications, the firm, will have to replace the fake/ sub-standard items with genuine ones immediately but they will also be liable to be blacklisted.
 - 2.7 Rate quoted by the firm should not be higher than the MRP/prevaling market rate.
 - 2.8 Conditional quotations are liable to be rejected. In the event of acceptance, Director's decision will be final. The rates should be quoted as per our required specifications. The quotation which is not as per our required specifications, will not be considered on any ground.
 - 2.9 The right to accept or reject any tender/ quotation, partially or wholly, including lowest quotation without assigning any reason whatsoever thereof or incurring any liability thereby is reserved with the Director, IIIT, Allahabad. The Director, also reserves the right to split the tender and place the orders for supply of item(s), mentioned in the enquiry letter on one or more tenderer.
