**TERMS AND CONDITIONS FOR DISPOSAL OF VEHICLES**

**1. Sealed Cover:**

The **Sealed Tender Bids** offering rates for the purchase of each of the vehicles should be addressed to the “**Deputy Registrar (S&P), IIIT Allahabad**” and be put in sealed cover enclosed with the following superscription “Tender for the purchase of condemned vehicles Registration No. \_\_\_\_\_”. The envelope should also bear the name, address and seal (if available) of the tenderer. The bids may be sent either by post or IN-PERSON dropped at the **TENDER BOX** kept at Office of “**Deputy Registrar (S&P), IIIT-Allahabad**”. Bids / Quotations received after the last date/time and without earnest money will not be entertained.

**2. Tender Form, Fees & EMD:**

The tender amount should be quoted only in the prescribed tender schedule enclosed (Ann – A). Rates quoted in any other form will be rejected. The Tender Form is available on Institute website: [www.iiita.ac.in](http://www.iiita.ac.in). The hard copy of “Tender Form” is also available at the “Accounts Section, IIIT-Allahabad, Jhalwa Campus” on Institute working days, on payment of a Form Fee of Rs. 500/- per form for each vehicle, either through Debit / Credit Card Swipe machine or in Cash. FOR EACH VEHICLE SEPARATE TENDER FORM SHOULD ONLY BE USED. An **Earnest Money Deposit (EMD)** amount for each vehicle separately as mentioned in the Advertisement “**Column 4**” should be deposited by **Demand Draft** in the name of “Director, IIIT-Allahabad” alongwith the sealed Tender Bid. If rates for more than one vehicle are quoted in the same tender schedule and WITHOUT EMD AMOUNT, the tender will be rejected.

**3. Inspection:**

The vehicles to be auctioned are available for inspection on “**as is where is basis**” with “**only visual inspection is permissible**” by the Tenderer at the “Parking Area, near Temple Premises, Jhalwa Campus, IIIT-Allahabad” between

3:00 pm to 5:00 pm on any day during the week. Bidders / Tenderers should inspect the Vehicles at the site and get satisfied of the conditions and quality of the vehicle to be purchased before offering the tender rate.

#### **4. Tender Opening:**

Tender will be received only upto the date and time prescribed in Para (1). All the Tenders received will be opened on **September 1, 2017 at 3:15 pm** by the Competent Authority at the **Main Admin Block, Board Room** in the presence of the tenderers or their authorized representatives (not more than one), who choose to be present. Only participated tenderers or their representative will be permitted.

#### **5. Acceptance:**

- (I) The tenderer should quote the rate for purchase of the vehicles both in words and in figures. If there is any difference in the figures and that in the words, the rate quoted in words will only be taken into account.
- (II) Price quoted by the bidder should not be less than the reserved price fixed for the vehicle by the authority.
- (III) The highest bidder shall not be allowed to withdraw his bid, failing which his EMD will be forfeited. The next highest bidder will be awarded for sale for that particular vehicle subject to that the next highest bidder is ready to pay the highest Auction Amount.

#### **6. Taxes:**

Applicable taxes admissible will be collected over and above the sale price in accordance with the Central Government Rules in force. As such the tenderer should quote the rate exclusive of Taxes while offering the rate in the tender.

#### **7. Payment:**

- (I) Successful bidder will pay 25% of the total amount on the spot after deducting the EMD Amount and the remaining amount will be paid within 5 days through **Demand Draft** in favour of "Director, IIIT-Allahabad", otherwise the bid will be cancelled and the amount will be confiscated. Bidders will also have to pay all the Government taxes admissible under existing rules. Also, the successful bidder will be responsible for getting the Registration Certificate of the vehicle transferred in his name and allied formalities from RTO at his own cost.
- (II) The vehicle will be released for delivery to the successful tenderer only after the full payment of the entire bid amount including taxes.

#### **8. Delivery:**

- (I) After complete payment and on receipt of delivery authorization from the Competent Authority, IIIT-Allahabad, the successful tenderer should remove the condemned vehicle from IIIT-Allahabad Campus at his own risk and his own cost within 24 hours from the time of receipt of delivery authorization, failing which a ground rent of 1% of the highest Bid Amount will be collected extra, for each day.
- (II) The person authorized by bidder will be allowed to take the delivery. The Bidders are required to produce any of documentary evidence for "proof of their address" with contact details.
- (III) The address given in the tender shall be "deemed to be Bidder's" address and correspondence sent on that address shall be considered to have been delivered to the bidder.

#### **9. Loss or Damage:**

Once the Tender is finalized and the entire Bid Amount collected and delivery authorization issued, Institute will not be responsible either for safe custody or for any loss or damage of the vehicles, beyond **24 hours on finalization of tender**.

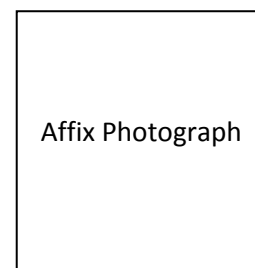
#### **10. Other Conditions:**

- 1. Bidders must provide attested copies of their PAN Card, ID and Address Proof (e.g. Copy of ADHAAR CARD, Voter ID Card, Passport, Driving License) and two PASSPORT SIZE PHOTOS duly self-attested.
- 2. The highest tenderer is responsible for all acts done either by himself or by his authorized representatives.
- 3. In case of any dispute, it should be clearly understood that the decision of the Director, IIIT-Allahabad shall be final.
- 4. The Competent Authority reserves all rights to accept or reject any tender or all without assigning any reason thereof and the decision of the Competent Authority will be final and binding on all.
- 5. The highest bid once accepted is not transferable to anyone, except in case of non-payment of bid amount / withdrawal.
- 6. All the tenderers are deemed to have read and accepted the terms and conditions herein mentioned.
