Detailed list of Documents required to be uploaded is also attached alongwith, which the candidate must keep ready in scanned pdf version for uploading on the IIITA ERP portal. While you are free to initiate these admission process related requirements from your place of convenience, you are also free to complete these requirements after meeting us personally during 13th – 18th August 2026. - * Schedule is dependent upon this activity and is subject to fine tuning in case of variations on this. So, it is advised NOT TO PANIC and wait patiently for the Portal to open. Any major changes in dates shall be flashed on the Institute website parallelly.
- 15th August is a closed Holiday.
- It appears advisable that admission seeking candidates, come to the Institute
 - after maintaining the soft copies of the required documents with them, as detailed herein further.
 - with their laptops , to enable quick uploading and avoiding waiting time on Institute provided onsite Computers.
- Requests by Parents / Guardians to provide preference owing to their return reservations on same day may not be possible to be entertained and are thus requested not to be made.

- Admission process takes time, so pl. remain patient.

Kindly note that the admission process is completed only after:

- 1) Your credentials are physically verified at the Institute & uploaded on the web portal,
- 2) Requisite academic Fees and Hostel/Mess Charges are received in the Institute,
- 3) Enrollment number is allotted to you,
- 4) Confirming your admission to CSAB 2026 is done, at the Institute. Your initiating the process of admission before reaching here in person, shall however hasten your admission process, once you are here. **Your personal presence alongwith the Certificates and Documents as detailed in attachments, in ORIGINAL are necessary at the time of admission, as per the Institute declared schedule after the CSAB 2026 declared schedule. The same will be declared on the Institute website – [iiita.ac.in](https://erp.iiita.ac.in). No personal intimation to any candidate is sent.**

IIIT Allahabad is a fully electronic payment compliant campus, where NO CASH / Demand Draft based transactions are undertaken. Fees are payable through ERP (<https://erp.iiita.ac.in>) ONLY.

Kindly ensure that you do not land up during the last hour of your allocated days for admission, just in case anything falls short, then we are constrained and unable to help.

For General Information for ALL candidates seeking admission at IIIT Allahabad through CSAB 2026

A. How to reach IIIT Allahabad:

By Train Connectivity:

Railway Stations at Prayagraj (erstwhile Allahabad) are as follows:

- 1) Allahabad Junction (PRYJ) – Abt. 7 kms from Platform No 1 side
- 2) Subedar Ganj Railway Station (SFG) – Abt. 3 Kms from either sides
- 3) Prayag (PRG) – Abt. 13 Kms. from Campus
- 4) Allahabad City (ALY) (also popularly known as Rambagh Stn)– Abt.10 Kms from Campus
- 5) Prayag Ghat (PYG) (also popularly known as Daraganj Stn)– Abt. 14 Kms from Campus
- 6) Jhusi (JI)–Abt 20 Kms. from Campus
- 7) Chheoki (ACOI) – Abt. 16 Kms. from Campus
- 8) Naini (NYN) – Abt.19 Kms. from Campus

The IIIT Allahabad campus is located at Jhalwa (Peepalgaon Road), Allahabad. Allahabad Jn. Railway Station is the first choice for reaching IIIT Allahabad followed by Subedar Ganj. Allahabad Junction is very well connected by Trains from all major places like Delhi, Kolkata, Guwahati, Mumbai, Chennai etc. Indian Railway services to Prayagraj are excellent and quite comfortable. Best is to alight on Platform No. 1 side of Prayagraj Junction and hire an auto rickshaw for about Rs. 200, depending upon day-night timings of your arrival. Ola Taxi Service is also available from

Platform No. 1 (locally called Chowk side) and also from Platform No. 6/10 (locally called Civil Lines side).

By Air Connectivity:

Allahabad is served by Bamrauli Airport, having the code IXD. Direct flights from Delhi (DEL), Bangalore, Mumbai, Raipur, Kolkata are available from here. It is about 4 kms from the Institute Campus. Ola Taxi again is available in between the Airport terminal and Institute Campus.

By Road Connectivity:

Own Conveyance—IIIT Allahabad Campus is accessible from the main Grand Trunk Road that connects Kanpur to Lucknow. Its 200 Kms from Kanpur and abt 203 Kms from Lucknow (The state Capital). As an identification point, take the road turning that is just opposite to the Dhooman Ganj Police Station on the GT Road and travel 2.9 Kms on the self guiding road, so as to reach the Gate No. 2 Entrance Gate (Main Gate) of the Institute.

State Roadways Bus – Alight at the Civil Lines Bus Stand, which is connected to all districts of Uttar Pradesh and also by Sleeper Buses from New Delhi. Civil Lines Bus Stand is about 10 Kms from the Institute Campus, from where local Autos / Battery Rickshaw as well as OLA Taxi is available round the clock. Shared Auto service is also available till upto Dhooman Ganj Police Station, from where another shared auto can be hired to reach Jhalwa Crossing, which is about 1 Km from the Institute Campus. Battery Rickshaws ply from there to Institute Campus. Reserved Autos are available from almost anywhere to anywhere, in Prayagraj (Allahabad).

B. Documents required at the time of admission:

One set of Clear Photocopied documents (A-4 Sized, self-attested) as follows are required to be brought by the selected candidate at the time of reporting. However, bringing ORIGINAL Copy of all Documents is MANDATORY to be brought for Verification. Reporting is to be done at Admission, Assessment and Award Section (AAA Section – Room No. 1713), in Administration Block of IIIT Allahabad for deposition at the Institute.**

Reporting Site: Room No. 1715, Admin Building, IIIT Allahabad, Jhalwa, Allahabad 211015. (NOTE - Generally the Institute Auditorium in Administration Block is maintained as the assembly area for all incoming New Candidates. Wash Room and Drinking Water facilities are available adjacently in the Building).

DOCUMENTS TO BE RETAINED IN ORIGINAL BY THE INSTITUTE:

1. Character Certificate from the Institution last attended. (In Original)
2. Transfer/ Migration Certificate from the Institution last attended. (In Original)
3. Income & Asset Certificate to Be Produced By Economically Weaker Sections (In Original) (Ann-1)
4. Medical Examination Report. (in the format attached). Medical examination Report may be got filled in from anywhere, including the candidate's home place. Pl. ensure that the same is duly signed and stamped by the Doctor. Doctor should also clearly state his/her MCI / State Council Registration No. alongwith the State in which Registered in case of State Council Registered Doctors.

OR else the same may be got done from IIIT Allahabad Health Centre Doctors against the payment of a fee of Rs 250/-. (In Original) (Ann-2 [B]) **IIIT-A Format**

Medical Examination Certificate submitted at the time of JEE Mains 2026 shall also hold good for the purpose. (In Original) (Ann-2[A]) – **CSAB 2026 Format**

(Note: Any one of above 2A or 2B is acceptable)

5. Anti-Ragging Affidavit by the **Student** (to be submitted on a Non-Judicial Stamp Paper of Rs. 10/-, duly notarized by the Oath Commissioner. (for deposition at the Institute), as per the format attached. **In Original (Ann-3)**)
6. Anti-Ragging Affidavit by the **Parent/ Guardian** (to be submitted on a Non-Judicial Stamp Paper of Rs. 10/-, duly notarized by the Oath Commissioner. (for deposition at the Institute), as per the **In Original (Ann-4)** format attached.
7. MCAIP Form for “Medical-cum-Accidental Insurance Benefit Scheme” (TWO SETs, to be **In Original (Ann-5)** deposited at the Institute).
8. STUDENT DECLARATION / UNDERTAKING FORM **(on PLAIN PAPER duly signed In Original (Ann-6) by Parent / Guardian & Student)**.

C. Details of Documents etc. to be uploaded on the web admission portal of the Institute (OPTIONAL):

- (i) GOOD QUALITY Passport size color photograph (35x50 mm size, upto 500kb size) and signature (10x30mm, 100 kb size, black coloured), both in .jpeg format. Photos MUST exhibit the complete full face of the candidate against White background without any hindrance by hair, hat/cap, goggles etc. Selfies are UN-ACCEPTABLE. Photos older than say 6 months from the date of admission are also UN-ACCEPTABLE.
- (ii) All academic qualification marksheets, certificate, CSAB Score Card in .pdf format at the time of registration or you may upload (in .pdf format, each file size upto 500kb) and fill all details at the student portal (please refer the link at page 1) before reporting at the Institute. Due to any reason, if you could not upload at the student portal, you may bring the documents in original for scanning and uploading at IIIT Allahabad. Documents in Original MUST be brought at the time of Admission.

D. Banking Facility:

- ATM counters of Canara Bank, Indian Overseas Bank and HDFC Bank exist at the Institute premises. Students can open their personal accounts also in these banks, who service the Institute, if they so desire.
- Bank Loan facilities are also available through a large number of banks, who usually set up their counters at the Institute Admission area itself during the admission period. You may connect with your local bank to understand the documents generally required by the banks for providing Student Education Loans.

(Imp Note: All admission time dues are to be cleared first, before any bank can grant you loans. Full admission time fee is NOT PAYABLE or SUBJECT TO your being allowed a Bank Loan)

E. Hostel Facility:

- The Institute is a fully residential campus and staying in the Campus is compulsory. All the Hostels (includes five Boys' Hostel & three Girls' Hostel) are provided with modern boarding and lodging facilities. Hostels have adequate Messing and recreational facilities including sports.
- Each student is provided with a Cot, Table, Chair and an Almirah space.
- The suggested list of items that may be required by a Hosteller during the course of his/ her stay on campus is likely to include the following:
 - ✓ One bucket with mug + soap with soap case + Door Lock (Good Quality)
 - ✓ Bedding with warm clothing, Blanket/ Quilt & Mosquito Net.
 - ✓ Temperature at Allahabad ranges between 7-10 in winters (December - January) and 40 – 49 in summers (April – June).
 - ✓ Table Lamp – In case you are habitual otherwise Tube lights are provided in all rooms.
 - ✓ Appropriate personal Clothing & Shoes.
 - ✓ Institute promotes Bi-cycles inside the Campus. Motor vehicles possession by students on Campus is NOT permitted. Institute maintains its own buses to cater to the local market visits of students during their stay in the Hostels. Ambulances are available to meet the emergent Medical instances.

You may accordingly arrange for the above things on personal basis. In case, your distance from home does not permit you to get any of these items from home, the same can be purchased from the local Jhalwa Market, near to the Institute Campus (About 1 km away). Allahabad Civil Lines Market, which is about 10 kms away houses showrooms/shopping Malls of all major brands. Additionally, all e-commerce sellers service the Institute Campus.

F. Medical Facility:

Round the clock medical facility is available at the Institute campus. Separate timings for OPD and Emergency purposes are pre-assigned. Additionally, MEDICLAIM cum Accidental Insurance Policy (MCAIP) is also available at the Institute for its bonafide students.

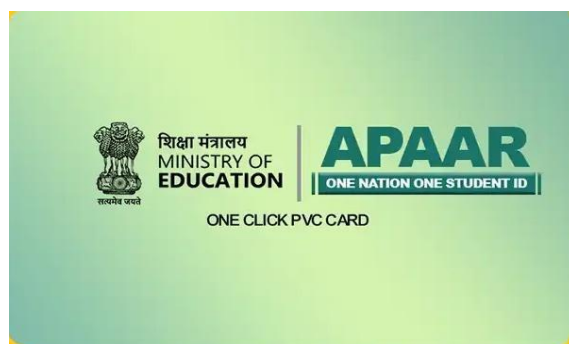
